Candidate for Sandusky County Commissioner Holly Elder attended meeting. Ms. Elder introduced herself, provided information on her background and why she is running for Sandusky County Commissioner.

Candidate for Common Pleas Judge Jon Ickes attended meeting. Judge Ickes provided an update on Common Pleas Court.

Candidate for Sandusky County Commissioner Scott Miller attended meeting. Mr. Miller provided an update on what has been going on with the county.

Mr. Brent Saionz provided the following report:]

- Began crack sealing and black top sealing. Will finish when weather permits
- Storm tile repair to the North River Road tile is tentatively scheduled in two weeks
- Erie Blacktop will begin paving soon
- Will install a "Slow Children" at the township park

Mr. Gilbert Overmyer received a complaint of semi's blocking the stop sign on West Birchard Avenue at Stone Street. Mr. Overmyer discussed with County Engineer Carlos Baez and he recommends placing a Stop Ahead" sign on West Birchard Avenue. Also discussed, placing a stop sign on the north side of the intersection. Mr. Saionz will have the area OUPS and will place a stop ahead sign..

Trustees received a letter of resignation from Pete Naderer from the Zoning Board of Appeals effective October 2, 2020.



Ms. Cyndi Zienta contacted Mr. Chris Michael regarding the damage to the sign by AEP. Mr. Michael did not have an incident report. Mr. Michael called the Sheriff's office to have one done. The Sheriff's deputy is having problems getting information from AEP regarding the accident. Mr. Mike Willis will get a status update on the report from Mr. Michael.

Once the report is received, Ms. Zienta will file with the insurance company.
Ms. Zienta provided a letter for Trustees to review. Letter is requesting the County Treasurer to foreclose on property located at 2650 Port Clinton Road and turn over to the Land Bank. Property is vacant, blighted and tax delinquent.
Trustees will submit request to the County Treasurer.

Trustees received the plat and legal description for the Bordner property. Mr. Jim Barney prepared the application for lot split. Trustees will submit to Sandusky County Regional Planning for approval.
